

## **TERMS AND CONDITIONS.**

THINKYOUNG AISBL organises, the THINKYOUNG HACKATHONS under the goal of making the world a better place for Young people by involving them in the decision making process, and by providing decision makers with high quality research and data on Young people`s conditions world-wide.

The THINKYOUNG HACKATHONS will be governed by the “Selection Process” published on the website [www.thinkyoungeu/hackathons](http://www.thinkyoungeu/hackathons) as, as well as by these particular rules accessible on the same page. The mere fact of applying to participate in THINKYOUNG HACKATHONS implies unconditional acceptance of the rules of the “Selection Process”, as well as these Terms and Conditions.

### **1. WHO MAY PARTICIPATE IN THINKYOUNG HACKATHONS.**

Non-Profit Organisations that meet the conditions of Section 2 may participate. The fact that the Non-Profit Organisation is part of a consortium in which organisations that do not have the status of Non-Profit Organization also participate shall not prevent it from participating, provided that it leads the project and has the necessary powers to sign the corresponding contract in the event of winning the project.

### **2. CONDITIONS THAT MUST BE MET BY THE PARTICIPANTS:**

Participation in THINKYOUNG HACKATHONS is conditional upon the applicant's meeting the circumstances listed below, which, by the mere fact of application, the applicant declares that it fully complies with:

- a) The applicant is a Non-Profit organisation and is legally incorporated in one of the EU Member States. In the case of being part of a consortium in which Profit organisations participate, the latter must not prove that they are incorporated in a State of the European Union.
- b) The person requesting participation on behalf of a Non-Profit organisation has the necessary powers to legally represent the organisation. That the participant Agrees to the Selection Process.
- c) The applicant organisation and, if applicable, the organisation in consortium with it, if any, complies EU and US sanctions, laws, and regulations, including data and privacy regulation.
- d) The applicant organisation complies with all international and EU labour standards.
- e) The applicant organisation complies with business licensing, tax, employee, and other regulations in all countries of operation.

- f) The applicant organisation keeps orderly accounts without resulting in a situation of insolvency or cause for dissolution of the organisation.

THINKYOUNG AISBL may require, at any time, the proof of the aforementioned circumstances.

### **3. INTELLECTUAL PROPERTY**

Intellectual Property rights developed with grants obtained through THINKYOUNG HACKATHONS must have open source code. Code must be licensed under the Apache 2.0 licence and other materials under the international CC-BY-4.0 licence.
